 - b. New bins will have QR codes can be scanned for information on trash separation
 - c. Bins will be delivered in February and pickup will start in March 2022
 - d. General trash = \$26.44 per month; Recycling and organic waste cans = \$25.47
 - e. If exempt areas opt-out of general trash pickup, mandatory to bring trash to transfer station once per week (\$30 charge for drop-off)
 - f. If Turlock Scavenger continued to pickup recycling in exempt areas, they could get fined up to \$10k by the State

SUBJECT:

Approval of a Resolution Establishing Stop Sign Controls on Anna Avenue at Amaryllis Way in Keyes and McCauly Avenue at Salluce Drive in Denair

STAFF RECOMMENDATION:

- 1. Approve a resolution establishing Stop Sign Traffic Controls on Anna Avenue at Amaryllis Way in Keyes and McCauly Avenue at Salluce Drive in Denair.
- 2. Authorize the Director of Public Works to take any appropriate action necessary to carry out the purpose and intent of these recommendations.

DISCUSSION:

Public Works staff is recommending the installation of all-way stop controls at two intersections in the County:

- 1. Anna Avenue at Amaryllis Way
- 2. McCauly Avenue at Salluce Drive

Anna Avenue at Amaryllis Way

The intersection of Anna Avenue at Amaryllis Way lies within the unincorporated town of Keyes, California. Vehicles on Anna Avenue travel in the east/west directions, while vehicles on Amaryllis Way travel in the north/south directions. There are existing stop controls on Amaryllis Way only and crosswalks present across all legs of the intersection. There also is the neighborhood Bonita Ranch Park located on the southwest corner of the intersection.

Prior to 2016, Anna Avenue began at its intersection with Motsinger Road and proceeded east until 10th Street where it terminated. From 2016 to present, this area saw the completion of the Bonita Ranch Subdivision Units 1 through 6 which added almost 400 additional single-family homes just east of the intersection of Anna Avenue at 10th Street. Anna Avenue was extended further east from that intersection creating a new intersection at Anna Avenue at Amaryllis Way. Numerous constituent inquiries have been made regarding what could be done to make this intersection safer. Reports of increased through traffic and near misses with vehicles and pedestrians were made.

An all-way stop analysis was conducted and it was determined through engineering judgement that all-way stop controls are warranted at the intersection of Anna Avenue at Amaryllis Way to reduce the potential for vehicle collisions involving pedestrians.

There are four crosswalks at this intersection, two being uncontrolled crossing Anna Avenue. There is a potential for increased pedestrian traffic using these crosswalks due to the adjacent Bonita Ranch Park and nearby elementary and middle schools.

Staff is recommending the Board of Supervisors approve the installation of all-way stop controls at the intersection of Anna Avenue at Amaryllis Way. Public Works Road Operations staff will perform all work to install the recommended signs and associated striping.

McCauly Avenue and Salluce Drive

The intersection of McCauly Avenue at Salluce Drive lies within the unincorporated town of Denair, California. Vehicles on Anna Avenue travel in the east/west directions, while vehicles on Amaryllis Way travel in the north/south directions. There are stop controls on Salluce Drive only and crosswalks present across all legs of the intersection. There also is a neighborhood park located on the southwest corner of the intersection.

An all-way stop analysis was conducted and it was determined through engineering judgement that all-way stop controls are warranted at the intersection of McCauly Avenue at Salluce Drive to reduce the potential for vehicle collisions involving pedestrians. There are four crosswalks at this intersection, two being uncontrolled crossing McCauly Avenue. There is a potential for increased pedestrian traffic using these crosswalks due to the adjacent neighborhood park and routes to nearby schools.

Staff is recommending the Board of Supervisors approve the installation of all-way stop controls at the intersection of McCauly Avenue at Salluce Drive. Public Works Road Operations staff will perform all work to install the recommended signs and associated striping.

POLICY ISSUE:

California Vehicle Code Section 21355 grants local authorities to erect stop signs in their respective jurisdiction. This project is a Class 1, categorical exemption under Section 15301(c) of the California Environmental Quality Act.

FISCAL IMPACT:

Each intersection will require six new signs and pavement markings: two stop signs and four all-way plaques. The cost to improve each location is approximately \$1,200 per installation, for an estimated total cost of \$2,400 for two intersections. Funding is available in the Fiscal Year 2021-2022 Public Works Road and Bridge budget.

BOARD OF SUPERVISORS' PRIORITY:

The recommended actions are consistent with the Boards' priority of *Delivering Efficient Public Services and Community Infrastructure* by ensuring that freight and vehicles travel safely and efficiently.

STAFFING IMPACT:

No additional staffing is required for the no parking zone creation or sign installation.

A RESOLUTION SUPPORTING THE INSTALLATION OF AN ALL-WAY STOP AT THE INTERSECTIONS OF ANNA AVENUE AT AMARYLLIS WAY AND MCCAULY AVENUE AT SALLUCE DRIVE

WHEREAS, California Vehicle Code Section 21351 Local Authority authorizes local jurisdictions to erect and maintain traffic signs, signals and other traffic control devices upon streets and highways; and

WHEREAS, the California Department of Transportation adopted the California Manual on Uniform Traffic Control Devices 2014 Revision 6 (CAMUTCD) to provide for uniform standards and specifications for all official traffic control devices in California; and

WHEREAS, Anna Avenue, Amaryllis Way, McCauly Avenue, and Salluce Drive are local highways not affecting state highway traffic; and

WHEREAS, Section 2B.07 Multi-Way Stop Applications of the CAMUTCD establishes criteria for the installation of Multi-Way Stop Signs; and

WHEREAS, criteria is based upon the traffic volumes, collision history, need for a traffic signal, and need to control conflicts; and

WHEREAS, Stanislaus County Traffic Engineering staff conducted engineering studies; and

WHEREAS, the findings satisfied the requirements in the CAMUTCD Section 2B.07 for the installation of all-way stop control; and

NOW, THEREFORE, BE IT RESOLVED THAT THE BOARD OF SUPERVISORS OF STANISLAUS COUNTY does hereby confirm the resolution for the placement of the all-way stop signs.
