  - f. Traffic on Lester – DUSD increased staff standing on Lester which has reduced bad behaviors with driving

**VI. Informational Items –**

**A. Update from Public Works**

- i. Bill Martins:
  - a. Flooding on Romie Way and Walton Road is caused by a clogged dry well on south side of intersection that will be cleaned this week
  - b. Utilize the STANCONNECT app to report flooding/over-watering
  - c. W Main/Fresno pump repair will occur in October 2022
- ii. Andrew Malizia:
  - a. Spring 2021 Safety Study was conducted by a consultant for the Monte Vista/Lester/Main intersections; they are on retainer for an after-safety study to evaluate adjustments made to the traffic signals (left turn only arrow onto Lester); the after-safety study will occur in October 2022
  - b. Growth has not impacted traffic patterns to warrant changes:
    - Monte Vista (Wenstrand Ranch development) – 70 vehicle trips per hour divided further by route the vehicle travels, only 25 vehicle trips per hour have been added to the Monte Vista/Lester intersection
    - Main/Waring development will add sidewalks on the north side of Main to connect existing sidewalk to schools
    - St Simon Way development added 12 units
    - Story Rd development will add 15 units
    - Zeering/Riopel development will add 60 units

- 2020 [California Environmental Quality Act](#) – no longer included calculation for delay through intersection; rather calculates for vehicle miles travelled – complex calculation that is not suited for smaller communities
  - Residents suggested the following improvements should be considered:
    - i. Adding THROUGH TRAFFIC DOES NOT STOP on stop signs
    - ii. Adding solar lighting/beacon on stop signs
    - iii. Removal of white line on east side of Lester, north bound lane to avoid confusing it with a stop line
  - c. No Parking Zone (Lester between Monte Vista and Main) – agenda item on October 2022 Board of Supervisors meeting for approval to red-stripe this area
    - Resident requested that school notify community when events are planned that may increase parking issues

- i. Legacy Health Endowment - \$75 million from the sale of the non-profit Emanuel Medical Center hospital to a for-profit company

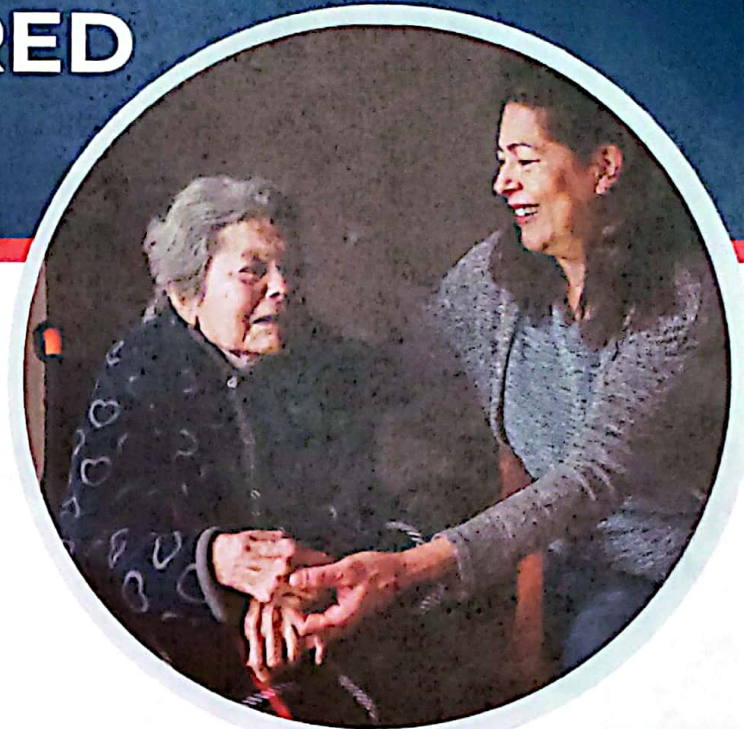

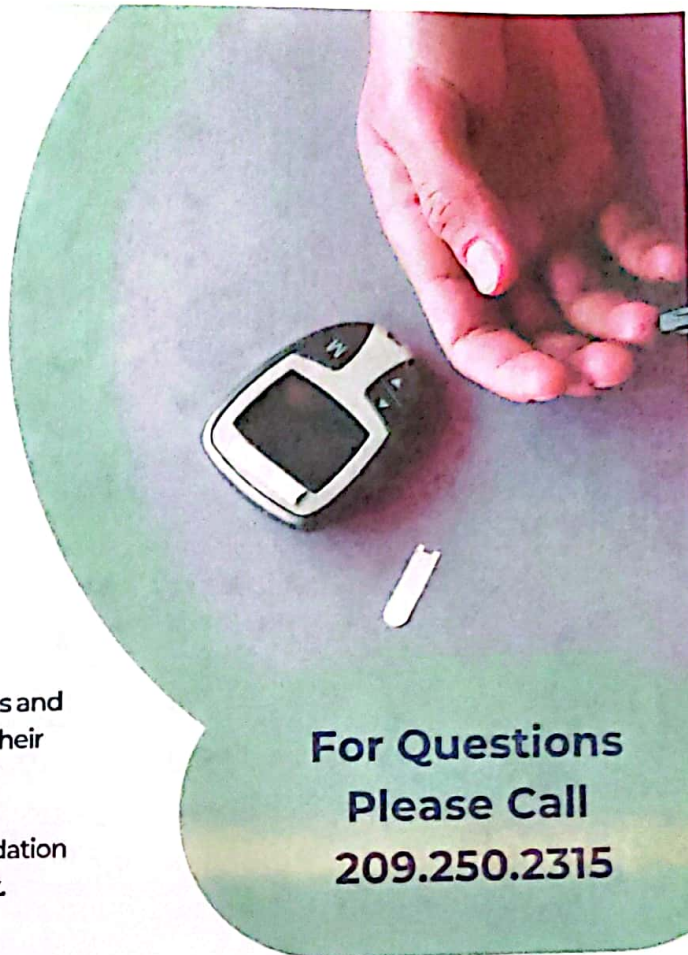


# \$2 INSULIN PROGRAM

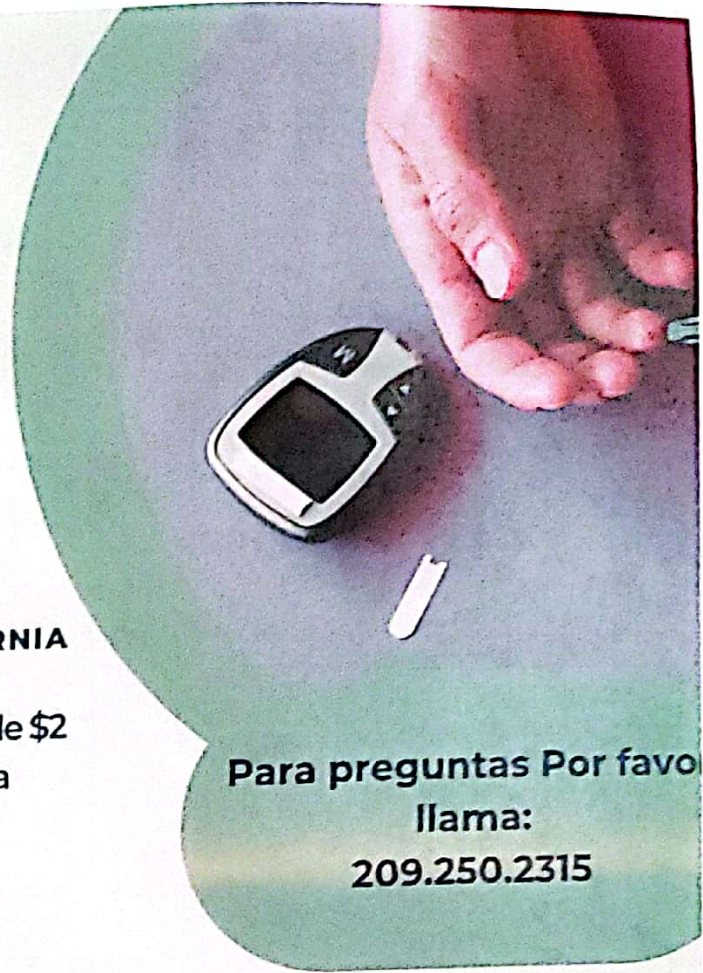

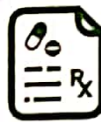
