THE FOLLOWING RESOLUTION WAS ADOPTED:

IN RE: ESTABLISHING A MUNICIPAL ADVISORY COUNCIL IN THE COMMUNITY OF KNIGHTS FERRY

WHEREAS, the Board of Supervisors has received a request to establish a municipal advisory council in the community of Knights Ferry; and

WHEREAS, the Board finds that the establishment of the requested municipal advisory council would increase the participation of Knights Ferry residents in decisions affecting the, and provide the community with official representatives,

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors hereby establishes, as of January 1, 1984, a municipal advisory council in the community of Knights Ferry.

BE IT FURTHER RESOLVED that pursuant to Section 31010 of the California Government Code:

1. The name of the municipal advisory council shall be the Knights Ferry Municipal Advisory Council;
2. The area for which the council is established shall be that territory presently within the Knights Ferry Community Services District;
3. The council shall consist of five members, each of whom shall be a registered voter or property owner within the Knights Ferry Community Services District;
4. The first members of the council shall be appointed by the Board of Supervisors. Subsequently, all members of the council shall be selected by election.
5. The council shall be empowered to: (a) advise the Board of Supervisors on planning, public works and public safety matters which affect Knights Ferry, and such other matters as the Board of Supervisors may designate; and (b) to represent the community any governmental agency or other organization on matters concerning the community.

6. At its first meeting, the council shall select two of its members who shall serve for a one-year term expiring December 31, 1984. The remaining three members shall serve two-year terms expiring December 31, 1985. Thereafter, all members shall serve two-year terms.
7. The council shall prepare and adopt bylaws for its operation. The bylaws shall become effective upon approval by the Board of Supervisors.
