#### **Minutes**

Tuesday – August 24th, 2021 - 7:00PM

Nick W Blom Stanislaus County Regional Library – Salida

4835 Sisk Rd, Salida, CA 95368

- 1. Call to Order and Pledge of Allegiance. L Powers Called the meeting to order at 7pm
- 2. Welcome and Roll Call. All Members present.
- 3. Approval of Minutes for the July 27th, 2021 Meeting. Motion to Approve 1st B Johnson / 2nd J Martin passed.
- 4. Public Comments:
  - Twila Tosh Superintendent Salida School District, gave an update on the School District. COVID protocols, students on independent study, vaccine requirements, Sisk Elem. remodel project.
  - Jolene Daily Introduced herself as a Stanislaus County resident, and a candidate for the 10<sup>th</sup> Congressional district.
  - Stu Gilman MID Director District 4, gave update on MID. No rate increase in the near future. Expressed frustration with the State of CA regarding water issues/restrictions/governance.
  - Juan Alanis Introduced himself as a candidate for Stanislaus County Sheriff in 2022

#### 5. Monthly Community Reports

- a. Stanislaus County Sheriff Officer January Siphon. Presented Crime Statistics for July. Question by B Johnson re: Vehicle Code enforcement. Officer Siphon said that funding via a grant has helped in increasing the enforcement.
- California Highway Patrol Officer Moore presented stats from July activity. Also mentioned that the CHP has benefited from some grant money, which allows more enforcement.
- c. Stanislaus County Supervisor, District 3 Supervisor Terry Withrow spoke about Stanislaus County Budgets, and the ability to fund and staff the Sheriff Sub-Station in Salida. He provided some history of the previous Salida Sheriff's Sub-Station.

Question came up about the development on North Pirrone Rd. The project has been put on hold while a wildlife study is considered. It is his hope that when this project comes before the Stanislaus County Supervisors, it will be held at an evening meeting so that the majority of Salida's residence can be in attendance.

There was a fire at a home in Salida, and T Withrow thanked Debbie Snyder for bringing the plight of the family to the Stanislaus County Services Agency and the Red Cross to get help for those folks.

- d. Salida Fire Department Chief Patrick Burns presented stats and reported on significant incidents. Stated that they have staff that is supporting fires throughout Northern California.
  - Question from B Johnson regarding a motorcycle accident, and a separate incident, a fire at the Salida Junkyard. B Johnson also mentioned that welding tanks are being stored near a gate. P Burns addressed the questions and will follow up with the junkyard about the tank location.
- e. Salida Sanitary District Brad Johnson reporting. There were some salary increases which were approved, the district was able to complete some projects without using outside labor/resources, saving time and money.
- f. Nick W. Blom Salida Regional Library –Wayne Philbrook gave a comprehensive report of the activities of the Salida Library. (<a href="http://www.stanislauslibrary.org/">http://www.stanislauslibrary.org/</a>) Kathrine Borges asked about the Friends of Salida Library Book Sale. W Philbrook said most likely in September.
- 6. Stanislaus Animal Services Officer Graham spoke about the upcoming Clear the Shelter event. (Aug 28th)

#### 7. Information Items

a. Presentation by Stanislaus County Public Works re: traffic study update. Dave Leamon and Andrew Malizia presented a traffic study of NE Salida. They are considering a signal at Sisk and Pirrone. As well as considering making Pirrone one lane (road diet), and/or, installing roundabouts. They were looking for feedback from the community. Overall comments were positive, as long as traffic is slowed down.

There is a bit of concern regarding crossing patterns for children walking to school using the Sun Glen / Indian Ridge Ln crosswalks across Pirrone. CLICK HERE FOR PRESENTATION SLIDES

b. Stanislaus County Sheriff Dirkse providing information on a possible Sheriff station in Salida.

Sherriff Dirkse and Captain Tory Hughes shared of the commitment and plan to have a Sheriff Substation in Salida. First preference for location would be West of 99, utilizing space in the Salida Fire Departments existing facility. Another option would be East of 99, utilizing space in the Stanislaus County Library - Salida

facility. There were staffing and budget numbers explained, and the plan is to staff Salida with 1 Sergeant, and 5 Deputies per shift. The goal is for full implementation of this plan for Mid 2022, with a commitment of those assigned to Salida beginning duties in April of 2022. ( although they may not be physically based in Salida yet. ) CLICK HERE FOR PRESENTATION SLIDES

Captain Hughes presented some staffing models (see attached Power Point to the Minutes for reference).

Community comments: "Should be West of 99,... near town center...". Question about funding, immediate and long term. Dirkse stated that the Sheriff's Office is committed to staff this sub-station regardless of upcoming funding/budgeting.

#### 8. Action Item(s)

MAC discussed communication outlets to formally inform Salida, and Salida Area residents of meetings and agenda.

B Johnson mentioned a sign notifying residents about upcoming MAC Meetings.

Discussion about utilizing social media outlets and Salida MAC E-Mail list to send out information about upcoming meetings. We will encourage Salida residents to provide us with e-mail address to get information out to them.

A question arose about a hybrid meeting (so people could attend "virtually") answer from E Inacio: that it could be difficult with technology and Brown Act was mentioned.

L Power motioned that a subcommittee be formed to research the sign. Design, verbiage, location, cost etc. B Johnson seconded it. Dave Leamon said he can help get that made and hung up in town. B Johnson will work with Dave Leamon at Public works to create a sign (or signs) to have in Salida promoting our MAC Meetings. Review of the signage will be an agenda item for next month. Motion amended that B Johnson and D Leamon will work on the sign and present a solution at the next MAC.

#### 9. Council Concerns/Comments/Suggestions for Future Agenda Items

- Request to add Stanislaus Animal Services as part of our monthly community reports.
- Request to add American Medical Response (AMR) to our agenda for September.
- All MAC Members reviewed and approved the letter to the Stanislaus County Board of Supervisors regarding the community's displeasure with response times.





#### Recommendations:

- Staffing: 6 Deputies and 1 CRU Deputy
  - 1. 4 Deputy for Beat 38: 7-12 work schedule. Day shift- 700 to 1900; Graveyard shift 1900 to 700
  - 2. 1 CRU Deputy: Focusing on a crime problem at a neighborhood level. 4-10 work schedule. Tuesday through Friday
  - 3. 2 Deputy for Beat 8: 7-12 work schedule, 1100 through 2300 as a backup for Beat 8
- II. Identifying a crime problem
  - 1. Communication with community members (e.g., MAC meeting)
  - 2. Work with a Crime Analyst to prioritize a task (e.g., identify the most prevalent crime, conduct crime pattern analysis etc.)
  - Collaboration Come up with ideas of how to address an identified crime problem at the MAC meeting. (e.g., targeted patrol, situational awareness to community members etc.)
