 - a. Department of Planning and Community Development Accept an update on Project PLN2021-0080; a Request to install a 59-foot tall Ferris wheel and amend the uses permitted in P-D (203), to allow for the sale and service of alcohol for on-site consumption at an existing amusement park on a 6.37± acre parcel in the Planned Development (P-D) (203) zoning district. The existing amusement park was approved by the Board of Supervisors on February 9, 1993 under Rezone No. 92-09 Camelot Park Family Entertainment Centers, Inc. Development Standards for P-D 203 specify a height limit of 35-feet tall. As part of this request, the applicant proposes to remove and replace the existing Go Kart track attraction from the project site to install the Ferris wheel. The proposed Ferris wheel does not conform to the development standards for the zoning district and, as such, a use permit is required to permit the Ferris wheel as proposed. Additionally, Rezone No. 92-09 did not permit the sale or service of alcohol on-site therefore a Use Permit is required to amend the permitted uses of P-D (203).
