- 5. Approval of Minutes Jul. 13, 2022: 1. Mr. Martin. 2. Ms. Osmundson; Unanimously approved.
- 6. Community Reports
  - A. Public Safety
    - California Highway Patrol: Officer Moore: Stats for Sept: No calls/complaints in Sept. 2022 as per the record. There are 5 patrolling officers countywide who patrol the Valley Home and surrounding rural communities.
    - Sheriff's Department: Not present.
    - Fire Chief: Not present.
  - B. Superintendent- Mr. B. Slikker: 1. Lock Down training and Knowledge Saves Lives, Staff and 1board member present for a 4-hour training. This program is to help keep students and staff safe. This was comprised of scenarios of a potential crisis on campus. Mr. Slikker stated there are needed improvements with the intercom and updated communication systems for safety. This was an intense program of interactive safety and crisis procedures.
  - C. Public Works No report. Ms. Inacio said the bridge of Pleasant Valley has reopened.
  - A. Supervisor -Not present. Mr. Condit sends his gratitude to Mr. Martin for his time and service to the Valley Home MAC. America Rescue Funds Act Workshops – As per Ms. Inacio, \$50 mil for infrastructure improvements were allocated for county pockets and unincorporated areas; several workshops to get community feedback

on how to best use these funds were held. (There are no projects scheduled in Valley Home.)

## 7. Information Items

A. East Side Mosquito Abatement District: Wakoli Wekesa, District Manager, has received many calls for the mosquito problems. Dr. Wekesa, brought two staff and explained their duties. There is a contract pilot that treats the area. Normally, there are ground scouts to survey infested mosquito areas. A series of hand out supporting information that discussed how to prevent mosquito infestation. It is needed to find where the mosquitoes are breeding. It takes multiple sprays to kill off the mosquitoes and to find their sources of where they are breeding. Once the source is found the pesticides are applied. (A resident said that our community needs to have a service truck that sprays for mosquitos as there were 20-30 years ago in the Valley Home Area.) As per Dr. Wekesa, there is a \$1,000 fine per property that is a mosquito breeding hazard. Residents must not have standing water on their property. The Mosquito Abatement is aware of the ongoing mosquito issues, but due to staffing shortages, not much can be done. Dr. Wekesa and the District confirmed that once more staffing is brought on, they will address the concerns of Valley Home.
