  - 8.1. California Highway Patrol: **Officer Moore** - the last three months included a couple of arrests, one car impound. The Tactical alert in effect requires 12 hour shifts and two patrolment per car.
  - 8.2. Sheriff's Office: **Deputy Carns, Deputy Cherry** – Crimes consisted of 30 family fights, 2 burglaries, 2 batteries.
  - 8.3. Salida Fire Protection District: **Pat Burns** – Calls are picking back up. Water rescues are increasing. Call 552-3700 for weed abatement. The County is again allowing firework sales.
  - 8.4. Woodland Ave. Fire Department: **no report**
  - 8.5. Stanislaus County Board of Supervisors: **Terry Withrow** – Wanted to applaud our County Sheriffs office and officers. Highly trained and prepared to defend the community. COVID 19 has 33 deaths in county. The County received funds from the Federal Government, will share with cities in county.
  - 8.6. Modesto Irrigation District: – **Stu Gilman** – reported how the shutdown affected them. Currently no shutoffs due to non-payment. They do plan to reschedule the reservoir tour.
  - 8.7. Hart Ransom Union School District: – **Matthew Shipley** - Coronavirus is going to change things. Gerianna Boer is retiring and a new principal, Cecelia Holt, has been hired. There will be options for students to opt out of on campus learning. Still working on distance learning features.
