3. Public Comment

They would also plan to improve fencing for safety and to replace 7 portable units with permanent structures.

3. The Middle School campus is looking into getting a new shade structure.
4. Denair Charter campus, which is separate from DECA, is actively pursuing grant funds to upgrade facilities.
- ii. It is estimated that the above projects will cost approximately \$45 million.
- iii. The school board is considering a local bond to replace the 2001 bond. Voting may take place as early as June so it can be prepared for the November 2024 ballot.
- iv. Ray Prock was nominated for the Stanislaus County Board Member of the Year.
- v. The housing development to the west of the baseball field is expected to be 69 homes, which the board expects could be an additional .7 students per home. There will be a 9ft maintenance road between the subdivision property line and the baseball field. The developer will also finish the sidewalk along Monte Vista down to Lester.
- g. 22nd Assembly District - Abby Pendleton, Assistant to Juan Alanis:
 - i. Assemblyman Alanis has proposed multiple new bill ideas, many regarding education and public safety. This includes AB 1796 addressed CTE, AB 1839 addressing grants for upcoming law enforcement officers, AB 1845 establishing a property crime program, and AB 1871 adding financial literacy to social sciences for grades 7-12

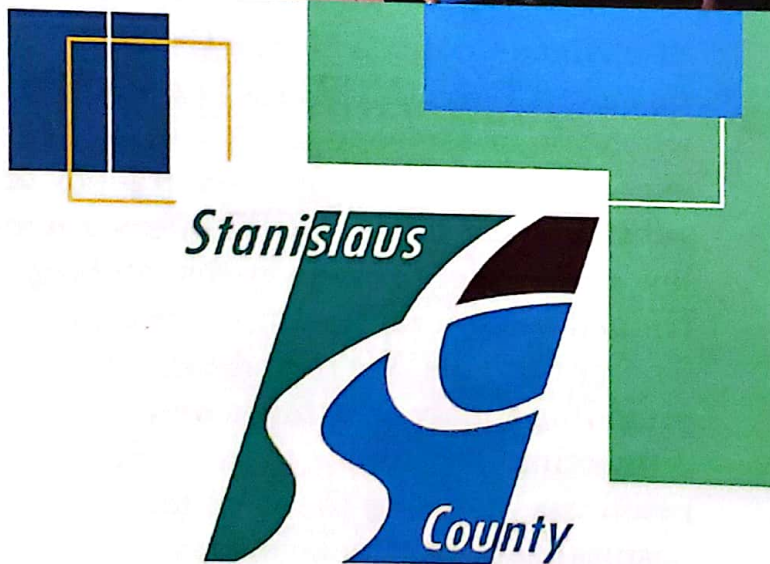

Mobile Crisis Response Team

Stanislaus County's Mobile Crisis Response Team (MCRT) is here to help when you or someone you know is experiencing a psychiatric emergency or substance use crisis. MCRT offers a non-law enforcement response, dispatching trained behavioral health experts to emergency calls. We're dedicated to providing timely assistance and connecting individuals to the right resources, reducing the need for hospitalization or incarceration.

Programs

Community Crisis Mobile Unit (CCMU)

- Clinicians accompany Law Enforcement officers in the field.
- Support staff assist with resource linking and follow-up.
- Also known as MCRT.

Mobile Crisis Emergency Response Team (MCERT)

- Clinician-partnered with officers to respond to crisis calls in the field.

Team Composition

- Behavioral Health Clinician (Modesto PD ride-along) with BHS support
- Behavioral Health Clinician, BHS support, and EMT (County Sheriff's assignment)
- Behavioral Health Clinician and BHS support for other local law enforcement agencies (e.g., Turlock PD, Ceres PD, Newman PD, Oakdale PD)

Responding to Requests

- MCRT responds to requests via the 911 dispatch system, 988 Suicide & Crisis Lifeline, and CERT Access Line.
- Legal authority for involuntary detention evaluations per Welfare and Institutions Code (WIC) 5150 and 5585.
- BHS Support staff link with community-based resources.

Crisis Intervention

- MCRT Clinicians engage through 911 dispatch, officer request, CERT Access Line Referral, and 988 Suicide & Crisis Lifeline.
- Safety is paramount; scene must be cleared.
- Clinicians build rapport, gather information, and perform crisis evaluations.
- Goal: Stabilize and connect individuals with appropriate support to avoid unnecessary hospitalization or incarcerations.

Trauma & Participant-Centered Evaluations

MCRT Clinician receive specialized training for goal-oriented participant-centered crisis evaluations. It involves interviews with individuals' family members and relevant parties to ensure safety and appropriate care

Training

- MCRT teams receive extensive training, including de-escalation, safety measures, and patrol operations.
- MH clinicians provide triage, screening, de-escalation, and crisis resolution.
- Focus on crisis evaluations, not comprehensive assessments for program admission.
- Ethical guidelines for evaluating individuals under the influence.

5150 Application

- Officers may sign 5150 applications when requested by MCRT Clinicians.
- Ensures compliance with insurance and placement requirements.

*Stanislaus Mobile Crisis Team (SMCT) 24/7

Starting January 1st, 2024, SMCT now operates 24/7, providing services year-round.

- Emergency crisis assessment/intervention
- Crisis/safety planning
- Early intervention and stabilization
- Coping strategies
- Consultation services
- Referral and resource linkage
- Support for parents, caregivers, and others

SMCT 24/7

***Community-Centered Care**

- SMCT offers a caring, non-law enforcement response.
- Rapid response within 30-40 minutes (based on availability).
- Focus on connecting individuals to services, avoiding hospitalization or incarceration.
- Ability to call for law enforcement assistance if needed.

SMCT 24/7

***Community Calls**

- SMCT handles community calls, offering information, referrals, and support.
- Accessible to all, including law enforcement and individuals in the community.

**NOTICE OF INTENT TO ADOPT A REVISED GROUNDWATER SUSTAINABILITY PLAN (GSP)
TURLOCK SUBBASIN**

The Sustainable Groundwater Management Act (SGMA) requires each groundwater sustainability agency (GSA) that intends to adopt a Groundwater Sustainability Plan (GSP) or revisions to a GSP to provide notice of such adoption to any city or county within the area of the proposed GSP (California Water Code §10728.4.) Pursuant to this requirement, the West Turlock Subbasin Groundwater Sustainability Agency (WTS GSA) and East Turlock Subbasin Groundwater Sustainability Agency (ETS GSA) hereby provide notice on behalf of their members that the GSAs intend to adopt a revised GSP no earlier than 90 days from the date of this notice.

The GSAs intend to hold public hearings to consider adoption of the revised GSP prior to July 16, 2024, but no earlier than 90 days from the date of this notice. The GSAs shall review and consider comments from any city or county that receives notice pursuant to California Water Code §10728.4 and consult with a city or county that requests consultation within 30 days of receipt of this notice. If you would like more information regarding the development of the revisions to the GSP, please contact Michael Cooke for the West Turlock GSA or Sarah Woolf for the East Turlock GSA using the contact information below. Information regarding the revised GSP will be included on the subbasin website at turlockgroundwater.org as it becomes available.
