- i. Stanislaus County Public Works (if applicable)
 - i. Stan County and TID have an agreement in place to fill the local canals from approximately March to November each year. During this time, local pumps are turned off and late-season rainwater cannot be pumped.
 1. A community member brought up potential safety and structural issues if that water is not able to be cleared from the streets and was referred to bring their concerns to the engineering department.
 - ii. Several community members brought up the locations of hazardous potholes in the community. These were noted by Public Works
 - iii. A MAC member raised concern regarding orchard trees blocking the view of oncoming traffic at Lester and Hawkeye.
 - iv. Jennifer Hidalgo - Design of the Sidewalk Project is currently in planning. Further funding will be granted in Section 6. Spring 2027 is the estimated start time for construction. There may be potential to advance funds and construction in the future.
- j. Stanislaus County Mobile Crisis Response Team - Horacio Madueno (1-888-376-6246, option 4)
 - i. Team is now able to receive calls directly from the public
 - ii. They are also dispatched as needed with Modesto/Ceres/Turlock police departments and Stan County Sheriff and CHP
 - iii. In May, they will be partnering with Telecare to provide 24/7 support and works with 988 suicide hotline.
 - iv. They are responding anywhere in Stanislaus county and to any community member, regardless of age.
 - v. April 2024, there were 141 dispatched calls (97 community-generated calls), 44 of which required hospitalization.

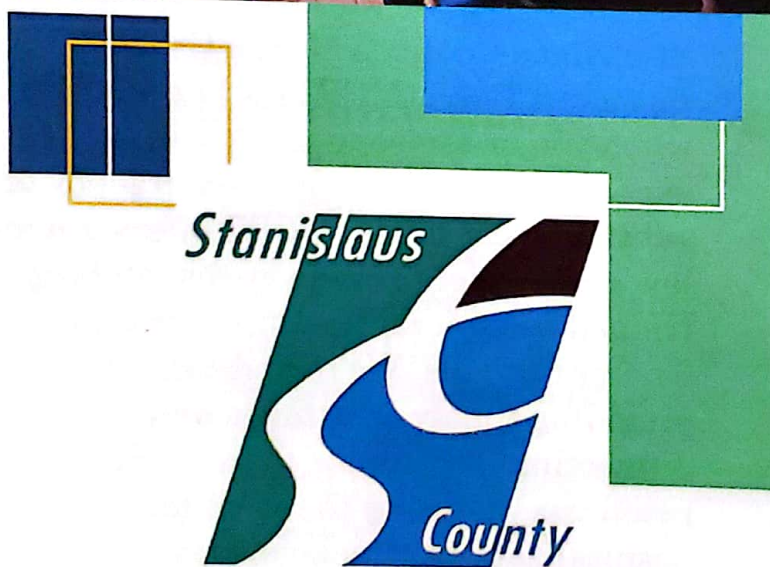

Mobile Crisis Response Team

Stanislaus County's Mobile Crisis Response Team (MCRT) is here to help when you or someone you know is experiencing a psychiatric emergency or substance use crisis. MCRT offers a non-law enforcement response, dispatching trained behavioral health experts to emergency calls. We're dedicated to providing timely assistance and connecting individuals to the right resources, reducing the need for hospitalization or incarceration.

Programs

Community Crisis Mobile Unit (CCMU)

- Clinicians accompany Law Enforcement officers in the field.
- Support staff assist with resource linking and follow-up.
- Also known as MCRT.

Mobile Crisis Emergency Response Team (MCERT)

- Clinician-partnered with officers to respond to crisis calls in the field.

Team Composition

- Behavioral Health Clinician (Modesto PD ride-along) with BHS support
- Behavioral Health Clinician, BHS support, and EMT (County Sheriff's assignment)
- Behavioral Health Clinician and BHS support for other local law enforcement agencies (e.g., Turlock PD, Ceres PD, Newman PD, Oakdale PD)

Responding to Requests

- MCRT responds to requests via the 911 dispatch system, 988 Suicide & Crisis Lifeline, and CERT Access Line.
- Legal authority for involuntary detention evaluations per Welfare and Institutions Code (WIC) 5150 and 5585.
- BHS Support staff link with community-based resources.

Crisis Intervention

- MCRT Clinicians engage through 911 dispatch, officer request, CERT Access Line Referral, and 988 Suicide & Crisis Lifeline.
- Safety is paramount; scene must be cleared.
- Clinicians build rapport, gather information, and perform crisis evaluations.
- Goal: Stabilize and connect individuals with appropriate support to avoid unnecessary hospitalization or incarcerations.

Trauma & Participant-Centered Evaluations

MCRT Clinician receive specialized training for goal-oriented participant-centered crisis evaluations. It involves interviews with individuals' family members and relevant parties to ensure safety and appropriate care

Training

- MCRT teams receive extensive training, including de-escalation, safety measures, and patrol operations.
- MH clinicians provide triage, screening, de-escalation, and crisis resolution.
- Focus on crisis evaluations, not comprehensive assessments for program admission.
- Ethical guidelines for evaluating individuals under the influence.

5150 Application

- Officers may sign 5150 applications when requested by MCRT Clinicians.
- Ensures compliance with insurance and placement requirements.

*Stanislaus Mobile Crisis Team (SMCT) 24/7

Starting January 1st, 2024, SMCT now operates 24/7, providing services year-round.

***Community-Centered Care**

- SMCT offers a caring, non-law enforcement response.
- Rapid response within 30-40 minutes (based on availability).
- Focus on connecting individuals to services, avoiding hospitalization or incarceration.
- Ability to call for law enforcement assistance if needed.

SMCT 24/7

***Community Calls**

- SMCT handles community calls, offering information, referrals, and support.
- Accessible to all, including law enforcement and individuals in the community.

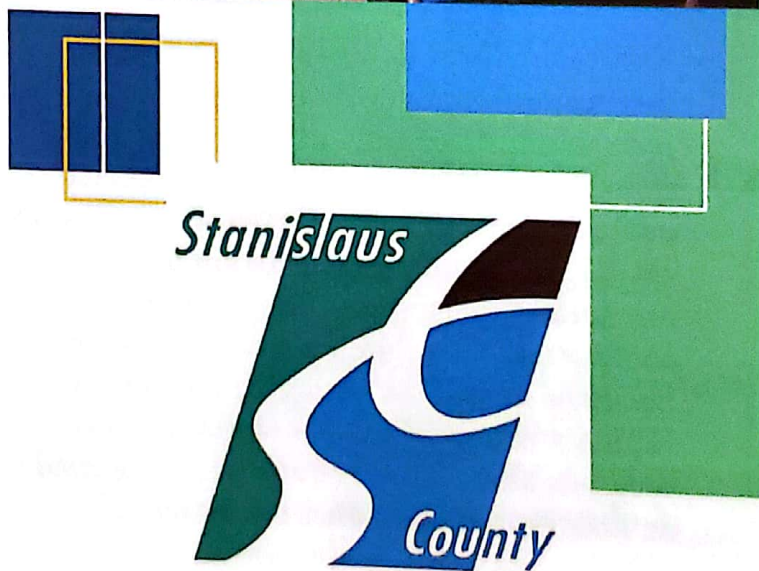

Equipo Móvil de Respuesta a Crisis

El Equipo Móvil de Respuesta a Crisis (MCRT) del condado de Stanislaus está aquí para ayudarlo cuando usted o alguien que conoce esté pasando por una emergencia psiquiátrica o una crisis por uso de sustancias. MCRT ofrece una respuesta sin policía, enviando expertos capacitados en salud conductual a las llamadas de emergencia. Estamos dedicados a proveer asistencia rápida y conectar a las personas con los recursos adecuados, reduciendo la necesidad de hospitalización o encarcelamiento.

Programas

Community Crisis Mobile Unit (CCMU)

- Los terapeutas acompañan a los oficiales en la comunidad.
- El personal de apoyo ayudan a conectar al siguiente día a recursos comunitarios y hacen llamadas al siguiente día.
- También conocido como MCRT.

Mobile Crisis Emergency Response Team (MCERT)

- El terapeutas se unen con los oficiales para responder a las llamadas de crisis en la comunidad.

Composición del Equipo

- Terapeuta de salud mental (acompañamiento de Modesto PD) con apoyo de BHS
- Terapeuta de salud mental, apoyo de BHS y EMT (asignación del sheriff del condado)
- Terapeuta de salud mental y apoyo de BHS para otras agencias policiales locales (por ejemplo, Turlock PD, Ceres PD, Newman PD, Oakdale PD)

Respondiendo a Las Solicitudes

- MCRT responde a las solicitudes a través del sistema de despacho 911, 988 Línea de Vida para El Suicidio y Las Crisis, y CERT Línea de Acceso.
- Autoridad legal para evaluaciones de detención involuntaria según el Código de Bienestar e Instituciones (WIC) 5150 y 5585.
- El personal de apoyo de BHS hacen conexiones a recursos comunitarios.

Intervención de Crisis

- Los terapeutas de MCRT participan a través del despacho del 911, a solicitud de un oficial, 988 Línea de Vida para El Suicidio y Las Crisis, y CERT Línea de Acceso.
- La seguridad es primordial; La escena debe ser despejada.
- Los terapeutas establecen una buena relación, acumulan información y realizan evaluaciones de crisis.
- Objetivo: Estabilizar y conectar a las personas con el apoyo adecuado para evitar hospitalizaciones innecesarias.

Evaluaciones Centradas en el Participante y el Trauma

El terapeuta de MCRT recibe entrenamiento especializado para evaluaciones de crisis centradas en el participante y orientadas a objetivos. Implica entrevistas con familiares de personas y partes relevantes para garantizar la seguridad y la atención adecuada.

Entrenamiento

- Los equipos del MCRT reciben un entrenamiento amplio especializado, que incluye reducción de tensiones, medidas de seguridad y operaciones de patrullaje.
- Los terapeutas de MCRT proveen un proceso de evaluación, clasificación, reducción de tensiones, y resolución de crisis.
- Enfoque en evaluaciones de crisis, no en evaluaciones integrales para la admisión al programa.
- Guías éticas para la evaluación de personas bajo la influencia.

Aplicación 5150

Los oficiales pueden firmar solicitudes 5150 cuando lo soliciten los terapeutas de MCRT. Garantiza el cumplimiento de los requisitos de aseguramiento y hospitalizaciones.
