Legislative Update- Office of Assemblyman Juan Alanis

Signed Into Law:

AB 2436: Protects California's Cattle Industry by supporting the department of Food & AG Bureau of Livestock identification program safeguarding against cattle theft and misappropriation.

AB 1902: Requires Pharmacies to provide accessible prescription medication labels to patients identifying as blind or have low-vision

AB 2324: Fights Food Insecurity & Reduces waste by allowing seized avocados to be sold or donated to on campus food pantries

AB 1946: Will Support California's Premier Thoroughbred Horse Racing Industry by expanding satellite wagering to include with prestigious Whitney stakes

AB 1880: Shield Child Content creators from exploitation by providing them the protection of the Coogan law

AB 1859: Fights the opioid crisis by requiring corners to test for and provide data of Xylazine (Tranq) in certain autopsy cases

AB 1871: Adds financial literacy to social sciences curriculum for grades 7-12

AB 1954: Increases Transparency and Public Safety for counties under consideration for placement of a sexually violent predator.

Assemblyman Alanis first term has successfully had 16 bills signed by the Governor into law
