- 1. Call to Order and Pledge of Allegiance
 - a. Jim Brugger called the meeting to order at 7:00pm and led the Pledge of Allegiance
- 2. Welcome and Roll Call

- 3. Public Comment
 - a. A community member expressed the need for a 4-way stop at Monte Vista and Waring and continues to advocate for traffic safety. Cited a recent collision in the area.
 - b. A community member inquired as to the speed limit on N. Gratton and brought concern of speeding in the area. CHP took note of the location and answered traffic related questions.
 - c. A community member expressed thanks to Public Works for maintaining the Fresno St pump.

 - a. Judy Kindle motioned to approve December 2024 minutes, seconded by Jason DeMuro.
 - b. Motion to approve minutes passed 5-0.

 - i. December call statistics: 88 total calls: 1 part 1 crime, 1 aggravated assault, 3 part 1 property crimes, 33 part 2 crimes including calls for disturbing the peace, vandalism, suspicious activity, and family domestic calls, and 8 warrant calls

 - iv. SB43 has passed and allows MCRT and law enforcement to administer 51/50 calls if needed and to provide information on mental health services.
