MEETING MINUTES

April 7, 2022, 7:00 PM

Hickman School Auditorium, 13306 Fourth Street, Hickman, CA

- I. Chair Clark called the meeting to order at 7:01 p.m. and led the Pledge of Allegiance
- II. Roll Call: Tonya Woody, Anna Rose and Meredith Clark (Absent: Ryan Reece)
- III. Chair Clark made a motion to approve February 3rd minutes, Member Rose seconded; motion passed.
- IV. There was no public present for Public Comment.
- V. Community Reports
 - A. Local Government:
 1. Erica Inacio (Chief Executive Office) – MAC elections will take place this fall. Hickman MAC has a vacancy term that expires in December and Member Woody's term is also expiring in December. Candidates apply with the county registrar, Ms. Inacio is available to answer any questions.
 - B. Public Safety:
 1. Capt. Ryan Marks (SCFPD) – There were 84 total calls in March; five fires and 26 public assists. Fire season is approaching, residents should remove all dead/dried vegetation up to 30 feet around house and buildings.
 2. Officer Eric Moore (CHP) – Two traffic impediments (one on Elma Street, also broken-down school bus at Lake Rd./Hickman Rd.); One arrest – drunken in public on Montpelier Rd/4th St; two vehicle non-injury crash at Lake Rd/Montpelier Rd; four reckless driving calls. Staffing: two officer transfers out, one officer in, for April; two officers transferring to Modesto office in July.
 3. Deputy Cody Cheary (Sheriff's office) – There was no representative from the Sheriff's office present.

- VI. Informational Items: Bill Martens with Public Works – Road repairs on Hickman Road (from Appling Rd. to Whitmore Ave.) will begin in June or July. Possible one-way traffic during repairs. Details will be made available at a later date. Canal bridge repair on Lake Road is complete. Hickman Bridge over Tuolumne River construction will resume when river water levels are lower in the fall.

- VII. Action Items – Member Woody made a motion to approve revising MAC meeting calendar from bi-monthly to quarterly (1st Thursday of every January, April, July and October); Chair Clark seconded; motion passed. Notices will be posted on MAC fb page, Post office and Hickman grocery to notify residents of this change.
