### Meeting Minutes

At 7:05 the meeting was opened with the Pledge of Allegiance to the Flag.

Meeting minutes for October 22, 2020 were approved. Meeting Minutes for February 25, 2021 were approved as noted with revisions.

#### Citizens Forum:

- 1. Army Corp of Engineers:** Heather Wright – Noted a thousand people illegally utilized the park during the COVID shut down, a Fire Lane must be maintained at all times, there is a Day Use Fee of \$4.00 which has been in place for 4 years. Recommends community members to attain a Life Time Pass. To help with parking, the Corp has opened the South Side Parking Lot. In response to potential use of North Lower parking, the Corp considers the area Culturally Sensitive and will only allow parking 3 times per year on special events. Heather recommends the community call the Sheriff to tow vehicle who are illegally parked in community. As a community shareholder the USACE has retained the Sheriff on Weekends costing \$750,000.00 per season. Heather announced her retirement and is training a replacement
- 2. CHP:** Eric Moore- Stolen Car recovered in area, staffing dropped due to Academy being Closed
- 3. Modesto City Fire:** Ryan Winton representing Modesto City fire was in attendance but was called to duty.
- 4. Sheriff's Dept:** Deputy Davis – 21 Calls, 5 Water Rescues, Black Truck reported as suspicious
- 5. CEO Office:** Erica Inacio in attendance – COVID Cases 52,357, 988 Deaths, 106 Hospitalized, 194,000 Vaccinated. April 18, 2021 – open to 50 and older, April 15, 2021 – 16 and older. Vaccination locations posted at the Post Office as received.
- 6. SC Public Works:** Phil Martin- To address Parking Issues, the County owns a Lot behind Vantine. Will review Ownership of Market Plaza. Also, let Community know of Roadside Cleanup in place.
- 7. Supervisor District One:** Buck Condit in attendance. Open to community. Call if needed. Will also review potential parking issues.

#### Old Business:

- 1. Green Book Update (dv):** No update.
- 2. Knights Ferry Campground:** Kristin Anaya – Campground has submitted Permit modifications, Historic Site Permit exist, however the new Owner wants to change conditions of permit. Actual Land Use, Environmental Resources all under review. Conditions of Approval are scheduled for review in May. The Army Corp has Easement to flood up to 8,000 CFM and need to review potential impact. They never received Preliminary Assessment
