Tuesday – February 25, 2025

**Nick W Blom Stanislaus County Regional Library – Salida**

1. Meeting called to order at 7:00pm – Pledge of Allegiance
2. Welcome and Roll Call – Members present: Debby Schneider, Karen Gorne, Brad Johnson; John Martin, Patrice Hoffman
3. January MAC Minute Approval – Martin/Motion to approve – Johnson/Second – Motion carried
4. Public Comment:  
Horacio Madueño – Mobile Crisis Team update
5. Monthly Reports:
  - a. Salida Sheriff – Detective Pfaff reported crime stats for January 2025. STARS volunteers will check resident houses if out of town. Recommended by Detective Pfaff all residents have home security cameras, even inexpensive ones.
  - b. California Highway Patrol – Officer Arias reported traffic statistics for January 2025. Shared Enforcing AB413 will be at CHP officers' discretion on parking on corners near crosswalks. CHP working with CalTrans to clear out homeless encampments on Hwy 99.
  - c. Stanislaus County Supervisor, Terry Withrow – EIR for Salida Community Plan still in progress. Did not recall anything regarding a Salida incorporation study. Nothing new to report on Scannell development. County has been approached by a developer looking to build homes off Toomes. Still working on 911 Dispatch Joint Powers of Authority and whether to stay together or not.
  - d. Salida Fire Department – Ed Bartley – Modesto Fire – 161 total calls for service. 2 structure fires. 2 vehicle fires. 2 vegetation fires. 97 EMS calls.
  - e. Salida Sanitary District – Removing solid waste project now in place. \$161,000 in bills for January 2025.
  - f. Nick W. Blom Salida Regional Library – Shared library activities for March 2025. Modesto Library move to Salida Library nearly complete.

  - James Pursley from Parks and Recreation gave an update on how CSA 10 funds have been spent in the past year and discussed future plans for Salida's parks and streetscapes.
  - Andrew Malizia returned to the MAC and shared ideas on some possible improvements to do traffic calming and relieve congestion on Broadway in downtown Salida.
