Comment: Chair Harrington, problems with trailers parking on Bystrum & Erickson. Comment: Member Villasenor, signs with "Kill the wetbacks" have been posted in their neighborhood. The Sheriff asked them not to take them off, but rather report it so they can have evidence of what's going on.

Captain Mayolo Bañuelos introduced himself. He was doing Officer Arias duties back in 2006. There is a difference between occupied trailers and vacant trailers as to how they can be removed.

 - All 5 Supervisors were present at the 4th of July parade, a great turnout from the public.
 - Working on having more "cooling" centers open.
 - Modesto Band conductor will be having his last performance at Graceada Park after 60 years.
