1. Call to Order and Pledge of Allegiance: 7:02 pm
2. Invocation
3. Roll Call: David Jones, Lina Ruggirello-Danzig, Todd Heinrich, Lori Wolf and Lisa Braden were present
4. Approval of Minutes for MAC Meetings
 - 4.1. March 13th, 2024 were approved as presented.
5. Public Comment – none.
6. Monthly Community Reports
 - 6.1. Stanislaus County Sheriff's Office – John Moss gave the call statistics for the month of May
 - 6.2. California Highway Patrol – Officer Moore gave us the news that the radar trailer has been repaired. He also reported the call statistics for May.
 - 6.3. Salida Fire Protection District – Ed Bartley with Modesto Fire reported on general information regarding the new recruits. He also gave call statistics for May.
 - 6.4. Stanislaus County Board of Supervisors – Terry Withrow reported details of the newly adopted 1.8 billion dollar annual 2024-2025 budget. Only \$ 307 million is discretionary. The rest is allocated by the State of California and a lot of the money goes to schools.
 - 6.5. Stanislaus County Chief Executive Office – We welcomed Jennifer Hidalgo as our new liaison.
 - 6.6. Modesto Irrigation District – John Boer reported on MID status. There is plenty of water this year. There is also a new peak plant going on line that operates on natural gas. It will be privately held until the five year transition period is complete and then will be under the MID umbrella. John also reported on behalf of the Woodland Ave. Fire department and gave their call statistics for May. Also that they have purchased two jet skis and are in the process of training for their use due to the high incidence of river rescue calls which they anticipate are going to be worse now that there is a new boat access on the Tuolumne near downtown Modesto and the new opening of Dos Rios State Park to the public.
 - 6.7. Hart Ransom Union School District – Matthew Shipley reported on current construction projects on campus including the renovation of the small gym with AC, lights, sun cans. Also a desperately needed fire alarm system that has never really worked right. And the biggest news of all is that beginning next Monday they will be opening a summer recreation program for an anticipated 40 students K-6th grade. They will be conducting this program

at their newly leased space on the off campus facility at the MJC West. The Hart Ransom school is looking for a new assistant principal.

Stanislaus County Mobile Crisis Team – Horacio Madueno reported on the newest information regarding their outreach programs to help with mental health issues to help free up law enforcement personnel unless their help is required. He provided flyers and cards with the appropriate phone numbers, including you can still call 911 or 988 which is the National Suicide Crisis Line. He gave the statistics for their calls for the month of May.
