However, California law prohibits the MAC from taking action on any matter which is not on the posted agenda unless it is determined to be an emergency by the MAC.

In order that interested parties have an opportunity to speak, any person addressing the MAC will be limited to a maximum of 3 minutes unless the Chair of the MAC sets a different time limit.

 - c. Salida Fire Protection District: R. Warton reported on July stats that included 177 calls, mostly for EMS; Fire District is providing support to Cal-Fires; New Fire Chief, Kevin Weiss as of June 20th;
 - d. Stanislaus County Board of Supervisors, Supervisor Withrow, District 3: None

Stanislaus County Chief Executive Office: Jennifer Hidalgo reported and provided the progress, status & funding of the Standiford/Beckwith Project; Currently project in the Project Initiation Document (PID) phase; Construction could begin by early 2028; Project intended to improve safety and provide facilities or bicyclists, pedestrians and transit users; Timeline: 2024-2025 for technical study; 2025-mid 2026 for Environmental Document; 2026 – 2028 for final design; 2028 anticipate to begin construction; Funding for project initiation and environmental phases provided by local capital facility fees and Regional Measure L funds. Funding for later phases including designs, the city plans to seek state and federal funding; Sign up for updates and questions at beckwith-standiford.com;

7. Information Item(s)

- a. Fentanyl in Our Community Presentation- Stanislaus County Behavioral Health & Recovery Services, Prevention Services. Jennifer Marsh presented: One Pill Can Kill Information included: Stanislaus county statistics on fentanyl poisoning/deaths in 2023 are 4-5 per week & main driver of overdose/poisoning deaths; Stanislaus County stats are rising compared to national rates; 7/10 pills confiscated by DEA contain lethal dose; 2ml (size of 1/2 grain of rice) is a lethal dose; overview of fentanyl and common street level drugs almost all contain it, many fake counterfeit drugs (Xanax, Oxycodone, Meth, Cocaine, Heroin) most victims are poisoned-unaware they are taking fentanyl; Drug dealers add fentanyl to addict returning customers, online drug purchase carry risk, social media used to traffic drugs-unlikely risk for RX/OTC products sold in pharmacies; Reviewed awareness of addiction vulnerability, stigma contributing to reduced community involvement, message to parents/families-talk to youth early and often and provide strategies for kids to refuse peer pressure; provided review on how to recognize signs of overdose; Narcan can reverse effects up to 30-90 minutes, often needs second dose; provided information on how to administer Narcan and emergency steps; Drug dealers are also adding Xylazine (animal sedative/pain killer) to street drugs-Narcan is not affective on this drug; Narcan kits and test kits for fentanyl and Xylazine were available for attendees/residents in addition to information leaflets in English/Spanish; For additional resources: Narcan kits, bilingual Fact Sheets, events and monthly coalition information can be found at StanRx.net or call 1-888-376-6246; Awareness Event: 8/31/24 "Not My Child" 5K Event 8 – 11am at the MJC West Campus; You Tube video documentary titled, "Dead on Arrival" (English/Spanish) (approx. 21 minutes)-published in 2020-note statistics have changed, encouraged to share.
